Use of personally owned devices in locker rooms, restrooms, and nurse's offices is expressly prohibited. Students are not permitted to use any electronic device to record audio or video media or take pictures of any student or staff member without their permission.

7. The student may not use the device to record, transmit or post photos or video of a person or persons on campus. Nor can any images or video recorded at school be transmitted or posted at any time without the express permission of a teacher.

Cook County Schools

From their MS/HS Student Handbook

Cameras, Cell Phones, Headphones and Electronic Devices

It is a privilege (not a right) for Cook County students to possess a cell phone and musical listening devices on school property. Students may maintain this privilege as long as the rules of use are adhered to.

Cameras are only to be used in school for class assignments, class projects or for teacher or principal approved occasions. Videotaping and photography without student or staff permission is prohibited. Under no circumstances should cameras (including cell phone cameras) be used in locker rooms or bathrooms. Students are expected to comply with data privacy at all times.

RIGHT TO PRIVACY Students shall not use cell phones, digital cameras or any other device to photograph or videotape other individuals at school or at school sponsored activities without their knowledge and consent. Students shall not e- mail, post to the Internet, or other otherwise electronically transmit images of other individuals taken at school without their expressed written consent. Use of cellular phones, cameras or other personal electronic devices is strictly prohibited in locker rooms and restrooms. Misbehaviors and Consequences

32. Nuisance Devices – Causing a nuisance with objects that cause distractions, such as MP3 players (iPods), pagers, radios, headsets, cellular phones, universal remote controls, laser pointers, etc. Use of cameras, cellular phones or other devices for photographic, audio, video or digital recording and/or sharing of those recordings without staff permission is prohibited.

Mounds View

Restrictions and Limitations on Acceptable Use

Access to the District's System is a privilege. The District may revoke the access of any user who violates any District policy or applicable law. In addition, users are prohibited from using the District System or personal electronic devices to send or receive messages, pictures, or documents that are fraudulent, illegal, pornographic, obscene, indecent, sexually explicit, discriminatory, harassing, defamatory, threatening, or which are intended to promote or incite violence against person or property. Any electronic recording, including audio and visual, or staff or students is not allowed without the express written permission of those being recorded.
