March 14, 2018 at Nordheim Cafe in Karlstad, MN. Registration will be at 5:15pm, meal at 5:30pm, and the


meeting to follow.

From the Field





I was recently at a meeting with colleagues and we were discussing the work Education Minnesota staff have done in regards to the "Value of Belonging" and the "Power of We" over the last two years. This lead to discussions about where Education Minnesota members are and how members feel about being a member of a union. We are all aware of the members who are "all in" and very active in the union, but we are also aware of others who are not so involved and may not understand

all the work we do and why we do it. This lead me to think about how we could help those who need to know more about what Education Minnesota does, as well as, why we do it. So...... this is my attempt to help all members know why it is so important to belong to your local, an intermediate organization, Education Minnesota, and the American Federation of Teachers (AFT) and the National Education Association (NEA).

To start, I feel it is important everyone understand what the term union stands for. In doing a quick search on the internet, the Oxford dictionary states one of the definitions of union as "an organized association of workers formed to protect and further their rights and interests; a labor union." To me, the key words in this definition are "their rights and interests". Why? In conversations with members, it seems much of the time, people belong to the union "in case I need representation." Yes, Education Minnesota staff are available to support you in any way we can, but belonging to a union is so much more than having access to an advocate when the need arises. It is about being together to support everyone's rights and interests, not just those of an individual person. It is all about WE, not me.

Knowing the definition of a union, what does that look like for you? Well, after a discussion at a Kramer-Brown Governing Board meeting last summer, I worked with Andrea Gross, Bemidji Office Professional Staff, to develop the diagram below.



Union begins with U!

As you can see, the union begins with U. Without U, the union does not exist. With U, it does exist and U come together to form a local unit of educators working in a school district. Many locals come together and form a larger organization known as Intermediate Organizations or IO. For U, your local, and 16 other locals, belong to the Kramer-Brown IO. This allows locals to come together to offer professional training opportunities that would otherwise be difficult for a small local to offer.

The KB IO also helps support attendance at state and national events, which would again be challenging for smaller locals to attend. The next level of the organization U belong to is the state organization, Education Minnesota. Education Minnesota has 86,000 + members of teachers, cooks, bus drivers, secretaries, and support professionals in many school districts across the state. Education Minnesota, along with other few other statewide ??? unions, belong to both AFT and NEA. Some of you may remember a time when there were two unions in Minnesota, the AFT and the NEA. Minnesota is one of a few states that merged these two unions in 1998. As a merged state, all members of Education Minnesota are members of both AFT and NEA. In a snap shot, these are all the organizations U belong to as a member of the union.

What does being a member really mean? Being a member of the union allows U to support and advocate for the entire group, not just one's self. When one member is harmed, we are all harmed. This is why we support each other as educators. This is why we also support other union brothers and sisters. We advocate for education and for students who do not have a voice. Who better knows what students need other than educators? We advocate for better working conditions and higher wages and benefits for all members. We provide members with professional development opportunities, allowing them to keep their license up to date. We fight for fair and equitable wages for all workers, regardless of race and gender. We stand up for the rights of those who may not have a voice. We stand up and fight because We Believe in We.

So..... I hope the information I have shared helps you understand why it is so important for members to Believe in We. There are many who are challenging the idea of Believing in We. They want to weaken unions by encouraging members to drop their membership. This will weaken unions, and We will not have as large a voice when it comes to negotiating or lobbying at the capital. Their ultimate goal is to destroy unions. My hope is that our members will stay strong and continue their membership so the next time I am in a discussion regarding what union brothers and sisters Believe, I can share that I Believe our members do understand, that they "Believe in We". Continued membership sends a statement that our members Believe in We, because Believing in We means We look out for and support each other as public educators. Believing means We continue advocating for public education. We do this by getting involved in one's local and supporting colleagues when issues arise. Believing in We means We organize and get involved in the process of helping protect public education. Believing in We means We get involved in the political process and work to elect representatives who support education and unions. Believing in We not only supports you, it supports WE.

As always, please do your best to be involved in YOUR Local. Remember, union starts with U. U working with other members will help us be successful in the future. Believe in the WE. Believing means WE can and will be successful.

Thursday ~ Parents/special guests had breakfast with their children.








2018 Education Minnesota Representative Convention

Education Minnesota is now offering two new professional development trainings, based on last year's Educator Policy Innovation Center report on trauma-sensitive, restorative practices.

"Introduction to Restorative Practices" and "Introduction to Trauma-Informed Practices" are now both part of the Education Minnesota Professional Training for Educators offerings.

"There is an alarming trend of the uses of exclusion practices, which leads to students' aggression both verbal and physical, students experiencing trauma and students mastering the art of breaking relationships and lacking the skills to repair them," said Gwen Johnson, an occupational therapist in the Northeast Metro 916 School District, who served on the team that created the EPIC report and helped develop this training. "However, I have seen the positive impact when a child is taught in a safe, nurturing and inclusive environment, when educators take the time to discover the function of students' behavior, and when children develop skills to repair relationships."

The restorative practices training will teach participants about the history and seven guiding principles of restorative practices. Four school districts in northwest Minnesota partnered in a 21st Century Community Learning Center Grant proposal and were selected to receive the 21st Century Community Learning Centers, Cohort 7 Grant on Sept. 1, 2017. The purpose of the funding/grant is three fold. First, to provide academic learning opportunities before school, after school, early outs, weekends, holidays, and summer enrichment programs. Second, it affords the grantees the ability to offer a broad array of additional services, programs, and activities, such as youth development activities, Career Readiness programs, STEAM/STEM programs, and character education programs, that are designed to reinforce and complement the regular academic programs of participating students. Third, it provides the means in which to create, and offer, family engagement learning experiences/



events. This remarkable opportunity for all students and their families, is the result of a four-school district partnership which includes Fosston, Win-E-Mac, Stephen/Argyle, and Waubun/Ogema/White Earth.

The 21st Century Community Learning Centers program is a federally-funded program that provides students a safe learning environment during non-school hours. The Center Coordinator at each site will provide and oversee a range of high quality services to support regular school-day academics and development, including but not limited to: tutoring and mentoring, academic enrichment, homework assistance, service learning, character education, STEM activities, the Arts, recreational activities, Math and Reading Literacy and dropout prevention. They also look forward to Family Nights, when adult family members actively participate with students through educational and personal development opportunities.

Should Millennials Be Your Money Models?

Gen Y is doing some things right when it comes to saving & investing.



ing risk averse & unaware. Is this truth, or is it fiction? In some instances, pure fiction. Here are some good financial habits common to mil-



lennials – habits their parents and grandparents might do well to emulate. Millennials are good savers. Last year, Bankrate found that about 60% of American adults younger than 30 were saving 5% or more of their paychecks. Only around half of the adults older than 30 were doing so. This difference is even more interesting when you think about the overhanging college debt faced by many millennials and the comparatively greater incomes of older workers. Twenty-nine percent of millennials were saving 10%

of their incomes last year, right in line with the average for other generations (28%).¹

EFS FINANCIAL ADVISOR Millennials value experiences more than possessions. Data affirms this view – in a Harris Poll of millennials, 78% of those surveyed said that they would rather spend their money on an experience or an event rather than some pricy material item. In contrast, some members of Gen X and the baby boom generation have spent too much money on depreciating consumer goods, with too little to show for it.²

Relatively speaking, Gen Y is less prone to drawing down its retirement funds. In the 2016 Transamerica Retirement Survey, just 22% of Gen Y workplace retirement plan participants said that they had tapped into a plan for a loan or a withdrawal. That compares with 28% of boomers and 30% of those in Generation X.³

Millennials are directing money into equity investments at a relatively early age. As Investors Business Daily reported in May, the median age at which millennials begin investing in these vehicles is 23. For Generation X, it was 26. Younger baby boomers made their first such investments at a median age of 32, and older baby boomers did so at a median age of 35. While roughly one-third of millennials are invested in equities, their comparative head start may help them compensate.4

They also embrace technology in a way that some boomers do not. The Internet is filled with financial information, and millennials may go out and learn on their own about investment types, tax laws, and saving and investing resources rather than waiting for a tax, financial, or human resources professional to explain things to them. While a little knowledge can be dangerous, having some information is better than none.

In short, the members of Generation Y are doing some things that may really pay off for their financial futures. Other generations might want to take notice.
