- Internal Audit Committee Training: We will take you step-by-step through the internal financial review process. This session will be beneficial for your internal audit committee members.

Bank account signatories: If you will be passing on your duties as treasurer to someone else or there have been changes to the signers, remember to update the information with the respective bank(s).

Thank you for all of your work as the local membership contact this past year. Your efforts and attention to detail are very much appreciated! Please forward any suggestions on how we can provide you with additional support.

Remember, all membership changes, cancellations and/or additions to your local membership roster must be received no later than June 15. Once the membership year closes, refund requests for dues paid in error or requests to add a member missing from the membership roster will not be considered. Please email michelle.johnson@edmn.org if you are not able to meet the June 15 deadline. Refer to the Membership Contact Handbook for roster change procedures, such as cancellations, etc.

In reconciling the April roster, you should compare it to the final dues deduction report to:

- Ensure each member's dues category is correct.
- Individuals no longer with the district are canceled.
- No member is missing from the roster.

Accuracy in reviewing and updating the membership roster in a timely manner preserves members rights. It also ensures the accuracy of dues billing statement because the monthly statement is based on the national and state dues listed on the membership roster.

If you would like a roster that contains both current and cancelled members and their assessment amounts, you can contact your local field office and they will email it to you.

eBilling statement

In the April newsletter, we announced a change to an online billing system. The instructions to obtain a temporary password and create your account are listed below. This system is set up with your email address as your username. As part of the account setup, you will request a temporary password. Membership contacts, treasurers and presidents have access to the new eBilling statement site. Locals will no longer receive a paper statement.

Common account setup issues:

- Extra spaces at the beginning or end of email or password.
- Entering the email in the user ID field and password field and then selecting forgot password.
- Individuals do not check the junk or spam folder for temporary password.

How to access eBilling

1. Open a web browser and copy this https://ims.nea.org/ebilling/ in the address bar. It will open to the log in page.

2. Your username is your role email. If you don't know your role email, try your home email. If you receive an error message, try your work email.

- 3. If you are unable to log in, email membership@edmn.org and request your role email
- 4. Enter your user name your email
- 5. Don't enter anything in the password field.
- 6. Select forgot password.
- 7. Locate your temporary password in this email account your email
- 8. If the temporary password email is not in your mail box, check your junk/spam folder.
- 9. Go to the log in site.
- 10. Enter your user name your email
- 11. Enter the temporary password in the password field.
- 12. You will be asked to create a new password.

Continuous Retired Membership

Help your retiring members stay connected. Please share the following information with any member who is retiring in your local.

Retired members help build unity and increase the power of Education Minnesota to represent educators and advocate for stronger public education. Now's the time to encourage retiring members in your local to register for Education Minnesota Retired membership.

Continuing as a member of Education Minnesota in retirement is FREE for those who:*

- Retired after Sept. 1, 2015.
- Have been a member for at least 10 years (special provisions for locals organized less than 10 years).
- Were an active member in good standing at the time of retirement.

Using their experience in education and flexible schedules, retired members can help build power in the union by:

- Volunteering and recruiting other members to engage in Education Minnesota campaign activities.
- Serving as ambassadors for educators and the union with community and service groups that meet in local communities.
- Providing mentoring services and support to locals and new educators.
- Covering hearings and lobbying at the Capitol for Education Minnesota's legislative agenda.

In addition, retired members get continued access to the ESI, NEA and AFT member benefit programs -- including Educator Employment Liability Insurance (ELL) coverage when teaching as a day-to-day substitute in public schools in Minnesota.
