

From the Field

As I write this article, it is teacher appreciation day. I want each one of you to know how appreciative we are of the work you do for the students of your community. I realize the last year and a half have been the most stressful of your career. From the stories you have shared, I know it has been more difficult than most people can imagine. Many administrators and school boards have unrealistic expectations. Parents and students expect you to be

available day and night. It is not easy trying to please everyone. Even so, you remain professional, show up every day, and provide the best education possible for the students of your school district. You do an outstanding job providing the best education a student can receive. Please know that we at Education Minnesota appreciate the hard work you do each and every day.

Since it is teacher appreciation time, I would like you to think about your colleagues and reach out to them with a few words of support and appreciation for the work they do. I also would like you to reach out to your local leaders, such as your local president, vice president, treasurer, membership contact, and negotiators. Besides teaching, these people have also been working hard to address all the unusual situations that have occurred because of the pandemic and the need for distance learning. The time these people have put in, on the behalf of member, is significant. Even before the school year started last fall I had one local president indicate that he already needed a break. Much of the work your local leaders do goes unnoticed, but believe me, there is a lot of work they do for all members. I encourage you to share a few words of support to these people.

As many of you are probably aware, this is a bargaining year. As your negotiators prepare or continue to bargain, do what you can to support their efforts. The pandemic has highlighted many areas that need to be addressed in bargaining. One of the areas is distance learning. Many of you are aware of this since you had the expectation to teach in-person and distance learners at the same time. Many districts have indicated they will continue to offer distance learning for the 2021-22 school year. In-fact, at least 60 new school districts have applied to MDE for approval to offer distance learning programs. If your district was not one of these, they can only offer distance learning to their own students. Even so, this brings up many questions and potential challenges. If you hear districts are contracting with firms like EdGenuity (owner of Compass Learning and Odysseyware), Florida Global Virtual Academy, Edmentum, Stride (used to be K12 inc.), and Pearson, this should be of concern to all members. There is evidence that using these companies is risky for students, some of which include the fact these companies lack validity, are notorious for student cheating, and have racial and religious bias.

I know all of you are tired and just want to get to the end of the school year, but if you learn your district is planning to use an online vendor to provide distance learning, please make sure your local president and bargaining team are aware of this. It would be

easy to just let this happen so you do not have to teach inperson and distance learning students at the same time. The fact is, besides the reasons stated earlier, if a district uses online vendors now and the local does not challenge this now, we could end up in situations where a district claims this work is no longer bargaining unit work. In the end, this might lead to reductions in teaching staff. We cannot wait. Now is the time to address situations where on-line vendors will be used to provide curriculum to distance learners.

Some of you may be wondering why Education Minnesota did not take a stand and prevent this from happening. Well, initially EdMN staff wanted to push back on the distance-learning situation continuing into the future. The fact is, it quickly became apparent distance learning was going to continue no matter how much we pushed back and what we did. It became apparent many parents, small districts, administrators, and school boards want this. The GOP and some Democrats also want this. I believe they are being short sighted and not considering the long-term damage it could do, especially to small districts. Taking all of this into consideration, it was determined our best option was to get involved in the process and do our best to put some rules and guidelines in place for distance learning programs. Getting these are important to prevent districts from doing whatever they want. In addition, there is a good chance distance learning is here to stay. Having good guidelines now will help address issues if distance learning does continue into the future.

As always, please do your best to be involved in YOUR Local. TOGETHER we can do so much. I would like all of you to know that I am here to help you in any way I can. Whether you have questions regarding your contract, negotiations, the new tiered licensure system, TD&E, health insurance, elections or any other item, please send an e-mail or give me a call. The three types of lobby days are:
 - Issue-themed Lobby Days: 4:00 p.m. on Wednesdays throughout session
 all members will be invited to these, and each week will focus on a different topic. We plan to start these in mid-January, and will send a schedule closer to that date.
 - Targeted Legislator Lobby Days: 4:00 p.m. on Tuesdays and Thursdays we are in the process of identifying legislators based on committee assignments and campaign targets. PA staff will be coordinating these events.
 - Local Lobby Days: Tuesdays and Thursdays members of the local only. These are the same as our past lobby days, except they will be held virtually. Other locals are encouraged to participate in their own lobby days and will work like they have in the past. Local presidents, field staff along with USM staff will schedule and coordinate their zoom lobby day, including set up and monitoring the zoom. They will do recruitment of members and scheduling with legislators. When the local or IO has decided on a date, they will contact Ashley Behrens to request a briefing. The briefing will be for 45

minutes and will be coordinated 45 minutes before legislators log onto the zoom. We will have our regular materials available, such as our legislative agenda, issue briefs, etc.

Two new EPIC reports focus on important education issues

Education Minnesota's Educator Policy Innovation Center will release two new research papers this spring in response to two education crises — improving equity in our state's child care system and responding to the disrupted learning brought on by the COVID-19 pandemic.

Minnesota's Birth-4 Care and Education System

Minnesota has an expensive and inequitable system for providing care and education for children ages birth-4, and it is a system that is in need of a dramatic overhaul. This paper reviews academic research and explores programs and practitioners across the country to find examples of more comprehensive, equitable care and education to their youngest learners.

In early 2019, Education Minnesota and ISAIAH began to wonder about the potential to partner together to improve equitable outcomes for birth-4-year-olds and at the same time lift up the workforce that cares for and educates those children, a workforce that has been systematically denigrated, undercompensated, and lacks access to the kinds of professional development our children need them to have.

Disrupted Learning, COVID-19 and Public Education in Minnesota

This EPIC paper reinforces that COVID-19 is not the cause of the inequities within the public school system; it is merely the flashlight that is illuminating the problems we always knew existed. The pandemic is certainly intensifying the structural problems that disadvantage too many students, especially students of color, but neither it nor educators are to blame for students being "so far behind."

Online dashboard shows why districts need fully funded schools

Education Minnesota has launched a new online platform to show a snapshot of what fully funding schools might mean in our school districts.

The web-based platform allows educators, staff, families, community members and legislators to see how a school district fares in the funding of certain categories.

The areas highlighted on the dashboard are only a few issues we must address to start the long process of building schools worthy of all students, regardless of race or address. This does not show everything a district needs to be fully funded.

How do we use the dashboard?

Go to <u>www.believeinwemn.com/dashboard/</u>. You will enter in the school district number or city that you want to view. Then you will go through three values-based questions to hopefully root the user in why these data points are important to student success.

The questions are:

- Should the state of Minnesota provide financial resources to close the racial-equity opportunity gap and to fully fund special education services and instruction for English language learners?
- Should schools provide the nurses, counselors, psychologists and social workers that our students need to get timely help?
- Should school funding in Minnesota be equitable and sufficient across the whole state, so that all students no matter what they look like or where they come from have what they need to succeed?

Users will see how much funding their district needs in that category to meet the suggested threshold, such as fully funding special education services, meeting the national ratios for support services staff or showing how much local levies have had to cover costs

Looking for a Great Field Trip: Visit an Outdoor Classroom Submitted by: Debra Koebernick, Greenbush-Middle River

The Greenbush Middle River first and second graders will enjoy a day of hands-on science learning at the Agassiz National wildlife refuge this year. One of the most important things the outdoor classroom does is teach students about the natural environment. The field trip focuses on understanding and appreciation of prairie wetlands and the animals that live there. Mrs. Schenkey, first grade teacher, said that students enjoy well organized stations with age appropriate hands on activities. Some of the experiences in the past years have included a nature walk using a clipboard checklist for things they need to look for on the walk, water stations where students are able to observe tiny organisms living in the water at the refuge, identifying animal tracks and making casts of tracks, hands on experiences with animal pelts, and learning about food chains by acting out the different roles of animals within those chains and appreciating the value of each one, even mosquitoes.
