#### IV. Adam Janiak: Unity Campaign

Adam J: No in person training until January 1, 2021

The launch of LearnUpon

Adam gave a quick tutorial. Catalog of classes is listed.

The current status is 8-12 classes being added. More are on the way.

All members can access this right now. It's on the website.

Monica B: Specific courses can be created for individual locals.

Beth J: Please do A,B, C on your own and then we'll meet together for discussion and question and answer. Another option as your members use this platform.

Whose turn is it to host the Relicensure Cycle this year? Richfield

Marc Created shared documents on what each district is doing for opening. Some have filled them in already.

# VIII. Adam Janiak: Taylor is our office support for Metro West. If any of your locals change officers, please let Taylor, Rose and Megan know.

On the EdMN website there are two sections:

A) Coronavirus section has an Expansion of paid sick and child care leave. Richfield has made a document that they have shared here. There are two—one for full time and one for part time employees. Excellent job Richfield. Thank you, B) Another section: Reopening Schools

Refusals to Work Due to Safety Concerns: Common Law and MN State Law Whistleblower Protection, OSHA-Protected Refusal and Work Stoppage Mid-Contract (Note: PELRA law)

Adam will follow up with links and documents.

How do we handle things that come up?

Safety checklist.

How are we going to be proactive in the moment when we see things that are concerning.

Ann H: What do teachers do if something on the checklist is missing? Do they go back into the classroom and work? If the administrator has not had the opportunity to correct it the teacher has to work. Call administrator and ask them to come to your room immediately.

Paula K: A form letter with safety requirements listed so a teacher can grab the form letter and fill out the form to mail off immediately.

Beth J: Who do teachers contact in their union and who in the administration to fix issues immediately

Instant Response team should be in place to handle a safe opening. The district must have this Instant Response Team. A point person and student within each building to go to.

C) School Building Reopening and Educator Rights

Personal Concerns / I am unable or do not feel comfortable returning to school or campus because...

Now: An executive order that has expanded the rights of teachers. The language is being interpreted in many ways.

There is no clear right to work from home; however, this order does not provide this right. The district has to have the discussion with the teacher. The rights that are provided go up and to a financial cap for the district.

On page 5, if you are on a hybrid learning model, "If distancing cannot be achieved in a space or on a transportation vehicle, the number of occupants must be reduced. "This refers to 50% / 6 feet distancing model.

Melissa B: Whose numbers should Orono be using? How are we going to find out what they are? How can we access that and

share it? They need approval by the state.

Adam J: We need to know what numbers you are using and how does your district fit into the model.

Marc D: MDH website updates the learning model every 14 days so districts can follow the learning rules model.

Marc D-H: Where does he find numbers for actual cases of Covid-- MDH (Under weekly report)

#### IX. What are your districts doing?

Ann H: We've been meeting with our members since the end of June. We are level 3 which is hybrid. K-3 will be meeting with their students. Teachers will be paired with a para as they move back and forth between 2 classrooms to accommodate the 6 foot distancing.

The high school will do distance learning 4 days a week and students will come in and meet with teachers in person or online on the 5th day. Observing distancing and numbers.

The middle school teachers will do a block schedule. The teachers will be meeting with approx. 150 students over the course of

A lively discussion on needs, intent, and safety ensued.

Where do you find subs if a teacher can't come to school? Same for paras as they have become the adult in the room?

Adam J: MDH has a Decision Tree for People with COVID-19Symptoms in Youth, Student, and Child Care Programs

A negotiations issue: Covid-19 leave

Kay C: Kids will be switching classes at one high school. Kids are expected to do the cleaning. Really? Adam: NO

If the cleaner is soap and water-OK. But there are certain requirements for disinfectants effective against Covid-19.

Ann H: Is it acceptable under the law to have students clean their desks? Adam will check.

Cory K: Mask aren't effective after 3 hours? Air handling of things? Adam: As you go through the steps set up for the school year, don't try to overwhelm your members. Frequently asked question sort of thing. Feel free to call Adam with questions. If you have members who have read the documents and can be a resource, use them if they agree to it.

Monica B: K-2 in building 4 days. 3-5 Cohorts The work load on these teachers as they deal with in class students as well as online students at the same time is too much for the teachers. Meetings are scheduled with the administration. A lot to work out before it goes to the board this week.

Kay C: Has anyone heard anything about too many teachers opting out to come back? Adam: One district does not have enough teachers to handle on-line learning. The rubber will hit the road in a couple of weeks and we'll figure it all out.

Marc D: What is the current number of people we've had to request leave so far?

20 want to work remotely from 1 building

15 teachers have requested leave

1/2 of staff want distance

1/2 of staff say with they'll return with safety conditions

- Marc D: Contact your city and see if they have CARES money they aren't using. Donate it to school district.
