1. Rodney Rowe: Legislative Piece

**Hybrid? Distance Learning?** 

Working with Heather Edleson. Distance Learning will be offered next year (one year commitment). Guidelines and boundaries are being established. Prep time. Number of students in class. In person and virtually are two separate jobs. Will be included in Education Omnibus Bill.

Currently, due to lower pupil enrollment, there will be a loss of funding. Gov including 25 million in bill to help cover loss of funding. The house will also include funding to help cover summer school costs, etc.

Assume both of above points will be in Education Omnibus Bill.

## 2. Bernie Burnham:

Three organizational goals – racial equity, full funding and strong unions.

Racial equity: Constant checking In on people. Currently we have local equity pilots going on. Racial justice planning committee. A group of staff working for the last 2 months (Race Forward) to help us do the work we need

to survey 220 people on staff and 220 people who are members. Paper concerning early childhool learning.

Through legislation there are several papers that include pandemic and race.

Under strong unions, we have calls with many from leaders to members. Teachers have the option to rejoin the union again this spring.

3. Questions: Chris Commers – potential for online learning in post pandemic. Chris's district did some polling and found there wasn't any interest in online learning post pandemic.

## 4. NEA Directors:

Marty Fridgen -

Most of the legislation talk was around Covid. Getting the money that schools need.

**Testing: They are NOT waiving tests for this year.** 

Lobbying for immigration reform. Also lots of energy around the national campaign.

Marty Scofield – Debating new amendments, resolutions, etc. virtually.

Questions: Mark Broten – How is Minnesotans doing compared to other states?

"We've had the opportunity to compare many states. We are all in the same boat trying to teach and the vaccinations. Issues with broadband access."

"A lot of other states took our information and used it to quide them."

"Our state is highly regarded by others."

"Nationally people are rallying around the George Floyd issue. Social justice issues have come to the forefront right now."
