Suicide Prevention AFT Session Session I

This session will focus on best practices in the area of suicide prevention. Note: Due to the sensitive nature of this training, facilitators will be licensed practitioners in the area of mental health. Please contact the Education Issues staff directly to coordinate a request for training.

Energize Yourself Session I

Feeling a bit out of sync, overloaded and lacking in energy? With this session, you can take some positive steps toward adding energy to your life! This session is full of great tips for you!

Trauma I: Understanding Trauma and the Developing Brain Session I

This course provides an introduction on the relatively new field of understanding the consequences of childhood trauma and what that means for educators. The course provides an overview of the original ACEs study, defines key terms and explores, at a basic level, how trauma impacts the developing brain. Understanding that dynamic opens up new doors for educators to stop causing further harm with traditional responses to behavior problems and to identify new ways to help students carrying high levels of toxic stress from exposure to childhood trauma to develop resiliency.

Supporting Transgender Students and Staff: Legal Issues and Best Practices Session I

Over the past few years, issues surrounding the rights of students and employees who identify as transgender have gone from relatively obscure to center stage. This presentation will identify legal challenges involving page transgender individuals, including an update on cases brought against Minnesota school districts, the Department of Education's partial revocation of its guidance regarding transgender students and cases across the nation.

Edpuzzle Session II

Edpuzzle is an excellent online tool that enables teachers to create or modify videos to ensure a more engaging learning experience for their students. Teachers have the ability to choose, crop, and modify videos by adding voice memos (recorded by you, the teacher!) and quiz questions. Students are prevented from skipping the video, and analytics are collected and are available to the teacher.

In this session you will be making a fall themed art project. Everyone can make this fall project. This session will cost \$5.00 to cover the cost of supplies.

Education Minnesota COVID Mitigation Protocols*



G. Field Office Report - Kevin Young

- THANK YOU!!! All the work you and other local leaders do for members is very much appreciated!!!
- COVID and 2021-22 School Year time will tell on what this looks like, but many believe much of the COVID guidance will be recommendations. If this happens, districts will have the ability to determine what the COVID protocols will be.
 - Locals are encouraged to inform districts that you want to be involved in determining what the COVID protocols will be.
- Summer School email sent to all local presidents on 6-3-2021 with information and template letter locals can use to request information regarding district's summer school COVID mitigation policy.
- Basically, much of the COVID guidance are recommendations, so districts will be able to
 determine what summer school will look like and what COVID protocols will be. It is
 important locals get involved in what the COVID protocols will be. This is especially
 important since most students participating in summer school will not be vaccinated.

- 4. Negotiations 2021-2023 Contract -
 - new this year is the ability to bargain tax-free student loan repayment accounts (bargaining alert sent)
 - b. Next year:
 - Locals need to start thinking about the needs of members if distance learning takes
 place in the future. Recommendation is to reach out to the district and express
 desire to negotiate this so everyone is ready in the fall of 2021. Items to consider:
 - If no executive order is in place:



- o 1) districts will not be required to offer distance learning
- 2) no KB IO districts have sent application to MDE to offer distance learning to students outside of district enrolled students - this means districts can offer online classes to enrolled students only
- 3) if there is no EO in place, requiring teachers to teach distance learning courses is a change in terms and conditions of employment. This is why locals need to demand to bargain any and all aspects of distance learning.
- As suggested earlier, locals should reach out to members what their experiences were like with distance learning. What worked? What did not work? What suggestions or ideas do members have?
- What do members need to be more successful?
- What is the best way to address days when a teacher is not available? Subs? Teacher covering for another teacher? Compensation?
- How should IEPs and SPED paperwork be handled?
- Home visits? Delivering of supplies?

By statute these positions are bargaining unit positions. Make sure to offer membership information and application. Again, document everything and keep records if an individual declines.

Foundation grants available throughout 2021-22 school year

The Education Minnesota Foundation for Excellence in Teaching and Learning will offer the following grants to eligible members during the 2021-22 school year.

The foundation is built on members helping members. By contributing only \$5 a year through dues, any active member is eligible to seek grant funding.

Professional development grants for teachers, ESPs and higher education faculty are awarded twice a year. Applications are due Nov. 5 and April 1.

ESPs and teachers may request up to \$1,500, and higher education faculty may request up to \$3,000. These grants might fund new instructional ideas, technology, working with parents, attending a conference, etc.

Educators may also submit a Professional Development Grant application for a group of members to either attend professional development or be trained at their worksite.

National Board Certified Teachers Scholarship applications are due Nov. 5.

Members can receive \$500 per component, up to \$1,000.

Classroom-focused grant applications are due Dec. 3.

These grants are available to licensed personnel who wish to improve their practice and student achieve. Applicants may request up to \$3,000.

Second-year classroom grant applications are due April 1.

Additional funding, up to \$3,000, available for projects continuing on for another year.

IMPACT grants to partner a nonprofit with the local union or school district. Applications are due Jan. 7. Approximately \$15,000 is available for one year.

Financial resources

Education Minnesota's Political Action Committee makes funds available to locals for use in campaigns. To be eligible, a percentage of a local's members must be contributing to the PAC. The contribution level for 2019-20 will be available in early fall. Additional funding may also be available for locals.
